

TERMS AND CONDITIONS

- a) You shall not use or permit the use of the Film Footage or the Materials for any other purpose other than its inclusion in the Production and subsequent exploitation in accordance with the Permitted Use;
- b) The BFI gives consent for the Licensee to edit extracts from the Film Footage into the Production in order to produce the required sequence provided that the editorial integrity of the Film Footage is not altered and is not added to or misrepresented in any way;
- c) You shall, at your expense, return the copy or copies of the Film Footage supplied by the BFI to the BFI in the same condition as when supplied to you immediately upon completion of the Production or provide evidence of its destruction as the BFI may require;
- d) The storing of BFI Material digitally in magnetic or optical media is prohibited without the payment of reproduction fees for all subsequent uses;
- e) You shall not assign charge licence, sub-licence or otherwise part with possession of the benefit or burden of this Licence Agreement without the prior written consent of the BFI except as provided herein for the purposes of exploiting the Production;
- f) The Production shall bear the credit 'BFI National Archive';
- g) In the event that the Licensee is at any time in breach of Clause 5(f) the Licensee hereby agrees and undertakes to pay the BFI the sum of £500 plus VAT within 21 days of such breach;
- h) The Licensee acknowledges and agrees that the BFI is only granting a right and licence in relation to the copyright in the Film Footage and the Licensee agrees to obtain all necessary rights, licences and clearances from third parties including but not limited to performers, participants, third party and underlying copyright, music and soundtracks;
- i) The copyright and all other such rights in all Film Footage (in any format original or copied) under this Licence Agreement shall be licensed to or belong to and be vested in the BFI and the Licensee shall not reproduce, copy or otherwise make use of the same in any manner whatsoever otherwise than expressly provided in this Licence Agreement without the prior written consent of the BFI. For the avoidance of doubt any editing or digitisation of the Film Footage by the Licensee shall not be deemed to create any new copyright therein and copyright in all forms and versions of the Film Footage shall remain licensed to or vested in the BFI.
- j) The Licensee shall promptly and fully notify the BFI of any actual, threatened or suspected infringement of any Intellectual Property of the BFI which comes to the Licensee's notice, and of any claim by any third party so coming to its notice that the exploitation of the Film Footage under this License Agreement infringes any rights of any other person, and the Licensee shall at the request and expense of the BFI do all such things as may be reasonably required to assist the BFI in taking or resisting any proceedings in relation to any such infringement or claim.
- k) You shall indemnify and keep indemnified the BFI from and against all actions, proceedings, claims, demands, costs (including without prejudice to the generality of this provision the legal costs of the BFI on a solicitor and own client basis) awards and damages arising directly or indirectly as a result or any breach or non-performance by you or any of your undertakings or obligations under this Licence Agreement;
- l) This Agreement shall be governed and construed in accordance with the laws of England and Wales, the courts of which shall be the courts of competent jurisdiction.
