Film on UK television 2010

In terms of audience numbers, the five terrestrial channels represent the most significant platform for film viewings in the UK, accounting for 51% of the televised feature film audience and 38% of all feature film viewings in the UK in 2009¹. This report outlines the number of UK and foreign language film transmissions on the terrestrial channels in 2010.

A total of 2,075 films were shown on the five main terrestrial channels in 2010, down 6% on 2009 (2,218 films). Channel 4 scheduled the most feature films (526) and BBC One the fewest (281), as Table 1 shows.

One in five (21%) of all films broadcast were of UK origin, down slightly on 2009 (22%). Over one third (36%) of films shown on BBC Two and just over a quarter (26%) of ITV1's film output was British.

Almost 8% of films televised in 2010 were recent UK titles (ie released theatrically in the 8 years prior to TV broadcast). Almost 14% of films shown on BBC Two were recent UK productions, as were one in ten on BBC One and ITV1.

Recent UK films broadcast on BBC One in 2010 included *Wallace and Gromit: Curse* of the Were-Rabbit, Flashbacks of a Fool, Breaking and Entering and The Flying Scotsman. Some of the highlights on BBC Two were The Damned United, In the Loop, Notes on a Scandal, The Other Boleyn Girl, Grow Your Own and Miss Potter. ITV1 screened Harry Potter and the Order of the Phoenix, Nanny McPhee, Elizabeth - The Golden Age and Hot Fuzz. Slumdog Millionaire, In Bruges, Looking for Eric, Stardust and This is England featured on Channel 4 over the year, while Five screened Outlaw, The Da Vinci Code and Layer Cake.




Figure 1 Number of feature films broadcast on terrestrial television, 2001-2010




Figure 2 Recent UK films as a percentage of the total number of films broadcast on terrestrial television, 2002-2010

The proportion of recent UK films shown on the main terrestrial channels has increased over the last eight years, from 3% in 2002 to almost 8% last year, as Figure 2 shows. In 2002, just 3.4% of films shown on BBC2 were recent UK titles, however in eight years this has increased to almost 14%. Recent UK films as a share of all film transmissions on BBC1 increased from 3.8% to 10% in that period and one in every ten films shown on ITV1 is now a recent British title, compared to less than 1% in 2002.




Figure 3 Foreign language films broadcast on terrestrial television, 2004-2010

The number of foreign language films shown on terrestrial television was the lowest since 2006, with 59 titles broadcast across the five main channels (see Figure 3). The leading broadcaster of foreign language films was Channel 4 which screened 50 in total including Indian titles *Om Shanti Om*, *Dhoom 2, Dev.D* and *Jodhaa Akbar*. Other titles broadcast on Channel 4 in 2010 included *Crouching Tiger, Hidden Dragon, Pan's Labyrinth, Volver* and *4 Months, 3 Weeks and 2 Days*.

Notes

- Details of feature film transmissions on UK television are assembled from the schedules by Attentional (www.attentional.com). The data reported are all films shown on terrestrial television in the calendar year and the data are a census not a sample. Country of origin is allocated by the UK Film Council Research and Statistics Unit and the UK share is calculated on that basis.
- 2. For the purposes of this analysis, a UK film is one which is certified as such by the UK Secretary of State for Culture, Media and Sport under Schedule 1 of the Films Act 1985, via the Cultural Test, under one of the UK's official co-production agreements or the European Convention on Cinematographic Coproduction; a film which has not applied for certification but which is obviously British on the basis of its content, producers, finance and talent; or (in the case of a re-release) a film which met the official definition of a British film prevailing at the time it was made or was generally considered to be British at that time. Most UK films in the analysis (including the major UK/USA films) fall into the first group films officially certified as British.
- 3. A full analysis of feature film on digital multichannel and pay-TV channels will appear in the forthcoming Statistical Yearbook 2010/11.
